NATIONAL, STATE AND LOCAL BICYCLE ADVOCACY: THE LEAGUE'S NATIONAL BIKE SUMMIT, WHICH JUST FINISHED ITS 10TH YEAR, IS THE U.S. BIKE WORLD'S PREMIER ADVOCACY EVENT. IN 2010, THERE WERE MORE THAN 700 ATTENDEES. THE U.S. SECRETARY OF TRANSPORTATION SPOKE AT THE MEETING, AND GOOGLE LAUNCHED ITS BIKE DIRECTIONS AT THE OPENING SESSION. AT THE NATIONAL BIKE SUMMIT, THERE WAS A BREAKOUT SESSION SPECIFICALLY GEARED TOWARD EDUCATING ADVOCATES ON BEST PRACTICES TO REACH UNDERPRIVILEGED COMMUNITIES.
